

# Grand Vue Park Pool Rental Contract

Please initial next to each statement verifying that you understand the terms and conditions.

1. \_\_\_\_\_ All guests of the party entering the pool facility will be counted against the number of passes for the rental, even if those guests will not be swimming. If you're planning to have a large party where all the guests will not be swimming, we recommend utilizing Richmond Hall as it has a viewing balcony and can accommodate up to 125 guests.
2. \_\_\_\_\_ Children must be 48 inches tall to ride the water slides.
3. \_\_\_\_\_ No modifications (to include changing a date) can be made to an existing reservation. The only exception, which must be made within 8 days of the event, is adding additional time. (If there are no other parties scheduled before/after the event).
4. \_\_\_\_\_ Dogs and other animals are not permitted in the pool shelter or Richmond Hall.
5. \_\_\_\_\_ Guests may not enter the Pool Shelter or Richmond Hall until 20 minutes prior to the scheduled party time (i.e. to decorate). There is a short window between groups and the pool staff need that time to clean, disinfect, and prep after public hours or a previous party. If renter has not vacated the area at the end of the rental period, additional fees will apply
6. \_\_\_\_\_ Please be respectful to following parties. Guests must clean up prior to their party's end time and are responsible for any damage to equipment, property, etc. No confetti, water balloons, sidewalk chalk, or "poppers". Please do not leave ice or food on the grounds outside of Richmond Hall or the Pool Shelter.
  - a. **Excessive clean-up (including the removal of staples) of the Pool Shelter or Richmond Hall will result in a minimum cleaning fee of \$100.**
7. \_\_\_\_\_ If a pool event is cancelled 30 days or more prior to the date, and an alternative date cannot be arranged, 50% of the payment will be forfeited and the remainder will be refunded.
8. \_\_\_\_\_ Cancellations made 30 days or less prior to the event will receive NO refunds and NO rescheduling unless inclement weather is forecasted (or occurs) on the day of the event
9. \_\_\_\_\_ Renters have an option to cancel the party due to inclement weather. \* Inclement weather is defined as 50% chance of rain or weather warnings issued by the National Weather Service
  - a. Parties may be cancelled no sooner than 24 hours before scheduled reservations due to inclement weather only.
10. \_\_\_\_\_ Please bring coolers for items that need refrigeration. There are no refrigerators available.
11. \_\_\_\_\_ Music must be appropriate and may not be played at loud volumes.
12. \_\_\_\_\_ Decorations must be plastic. Do not decorate with crape paper or anything that will leave a stain if it gets wet. Please do not use staples or command strips – Please use tape or string to hang decorations.
13. \_\_\_\_\_ Pool party guests may bring outside food and drinks. NO alcohol or glass permitted. **Food may not be brought into the general pool area before, during or after the party. Food must be completely removed from the pool area once the Pool Shelter reservation has completed – Bringing coolers into the general area is not permitted.**
14. \_\_\_\_\_ One vehicle is permitted by the Pool Shelter.
15. \_\_\_\_\_ All guests must enter through the Main Entrance of the pool. The gate to the back area of the Pool Shelter will be locked once the sole guest vehicle is parked.
  - a. If a guest requires mobility accommodations arrangements can be made prior to the party to allow the guest to enter through the back gate of the pool.
16. \_\_\_\_\_ If drugs or alcohol is observed during the party the group will be asked to leave and will be prohibited from entering the pool in the future.
17. \_\_\_\_\_ All posted rules must be followed, and lifeguard commands must be obeyed.

18. \_\_\_\_\_ Parents or responsible adult guardians must supervise his or her own child.
19. \_\_\_\_\_ All children who are not potty-trained must wear a swim diaper. Regular diapers may burst or leak.
20. \_\_\_\_\_ *APPLICABLE FOR FUNDRAISING EVENTS ONLY.* If the facility is being rented for monetary gain for an organization or person the said parties must provide proof of insurance with Grand Vue Park - Marshall County Park and Recreation 250 Trail Drive Moundsville, WV 26041 as the certificate holder on the insurance. The renter shall provide a full force and effect comprehensive liability insurance policy with a minimum amount of \$1,000,000 combined single limits of bodily injury and property damage liability, with a general aggregate limit of \$2,000,000 for more than once occurrence or accident, covering liability that may arise during the term of the agreement.
- a. The renter must also remit an agreed upon percentage of the gross sales to Grand Vue Park in addition to the rental fee.
